
TOOLS REQUIRED

RATCHET

3/4" & 7/8" SOCKET

TORQUE WRENCH

FISHWIRE TECHNIQUE

INSERT COILED END OF FISHWIRE TOOL THROUGH HITCH MOUNTING HOLE IN VEHICLE FRAME RAIL AND OUT THE ACCESS HOLE. PASS COILED END OF FISHWIRE THROUGH SPACER AND THREAD BOLT INTO COIL. KINK WIRE TO KEEP SPACER SEPARATE FROM BOLT AS SHOWN. PULL FISHWIRE, SPACER, AND BOLT THROUGH FRAME AND OUT MOUNTING HOLE. USE FISHWIRE TO GUIDE HITCH DURING MOUNTING AND PREVENT LOSS OF BOLT / SPACER INSIDE FRAME RAIL.

NOTE: SOME VEHICLES MAY FISHWIRE THROUGH END OF FRAME

INSTALL NOTES:

- NO DRILLING REQUIRED
- FISHWIRE IF NECESSARY

INSTALLATION STEPS

1. Install all hardware and spacers, as shown above. Using fishwires may help to pull hardware through holes in frame rails. **NOTE:** Be sure 9/16" hardware is used in the vehicles rearmost mounting locations.
2. Raise hitch into position and attach with hex flange nuts, as shown above.
3. Torque all 1/2" hardware to 110 ft-lbs and all 9/16" hardware to 150 ft-lbs.

PERIODICALLY CHECK THIS RECEIVER HITCH TO ENSURE THAT ALL FASTENERS ARE TIGHT AND THAT ALL STRUCTURAL COMPONENTS ARE SOUND.
